Delegates will develop effective auditing skills and knowledge of current best practice to aid continual improvement through focussed OH&S audits. Successful implementation of the course meets part of the formal training requirements for individuals seeking registration under the IRCA Auditor Registration Scheme.

- 4-Realize the role of the lead auditor.

- 6-Develop audit strategies.
- 7-Plan and conduct an audit in line relevant OH&S audit criteria.
- 8-Write nonconformity and audit reports.
- 9-Excute follow up activites.
- 10-Realize lead auditor duties and competence issues.
